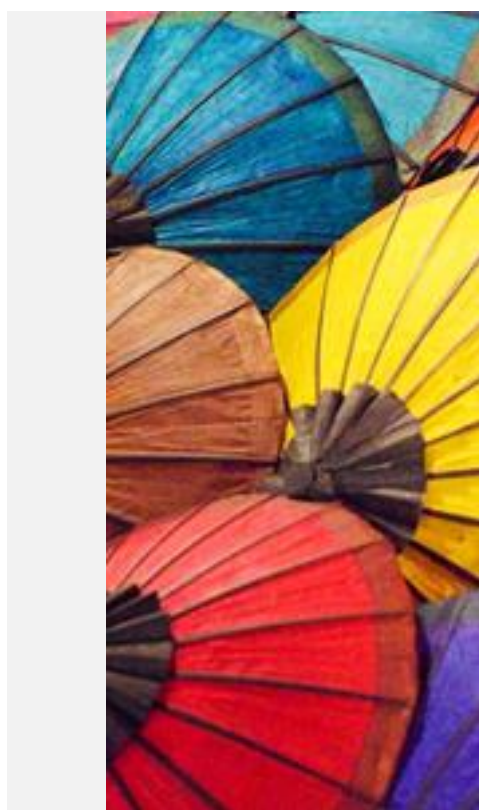

15:15 *How can comparative evidence help support public sector productivity and governance reforms in ASEAN countries?*

Topic: Governments are trying to improve public sector productivity to strengthen public services in the face of financial pressures and citizen demands. However the public sector faces a double challenge: the measurement of productivity is not as straightforward as it is for the private sector, and there is a lack of evidence on the drivers of productivity – the public management practices and their impact on productivity. The OECD is starting work on public sector productivity. How can ASEAN countries set an agenda – for example through the SEA G@G – to standardise and compare data to better inform their own reform agendas?
